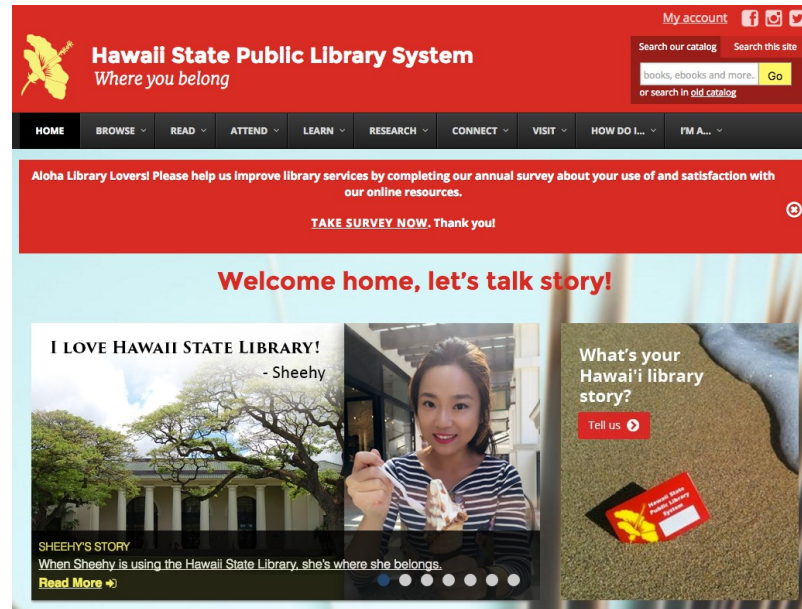

Highlight 1 – New HIC General Manager



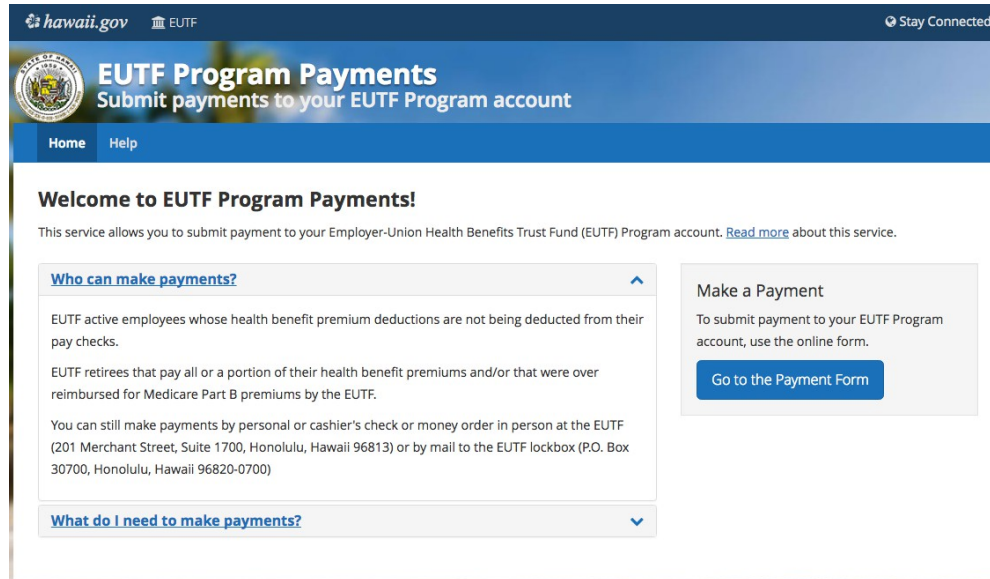

Highlight 3 – EUTF Program Payments



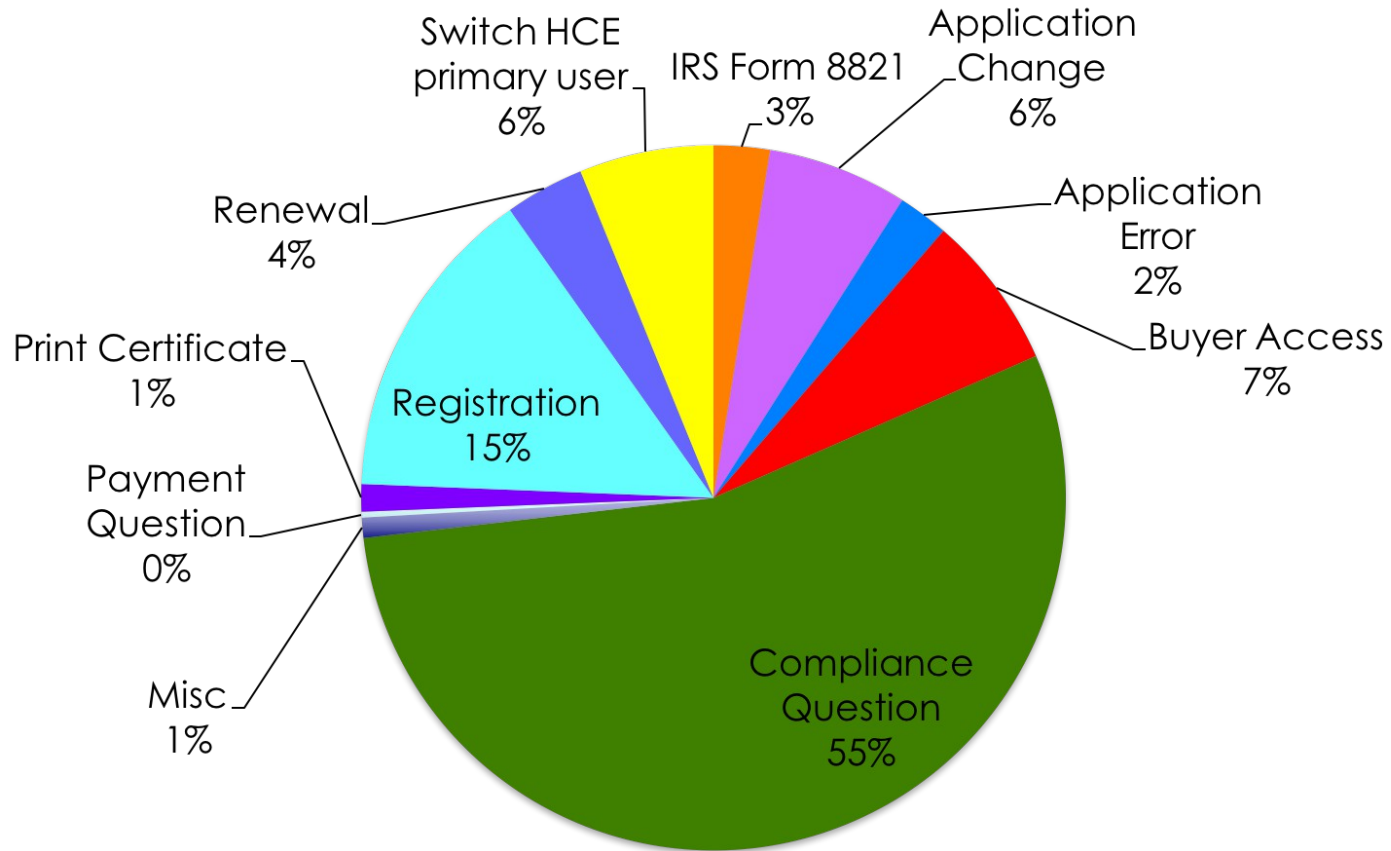

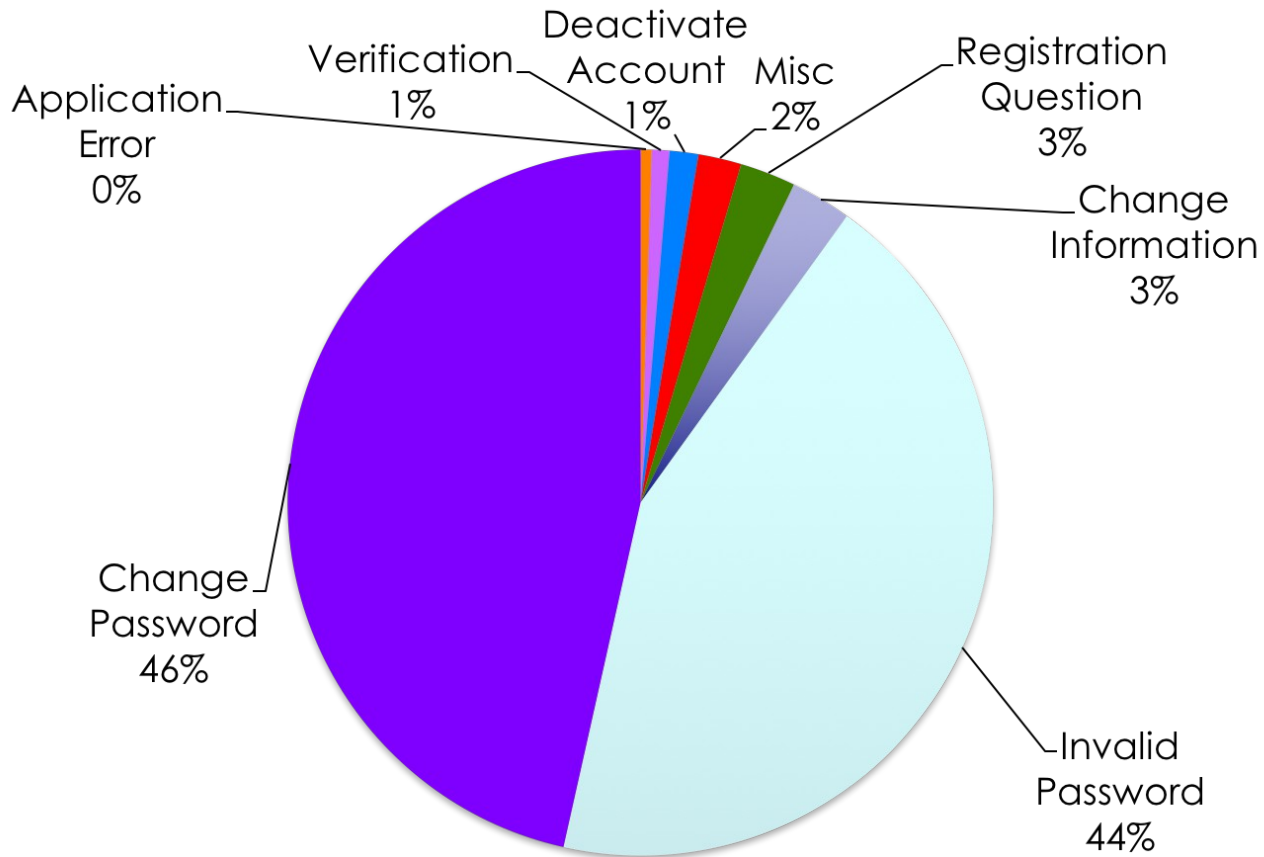

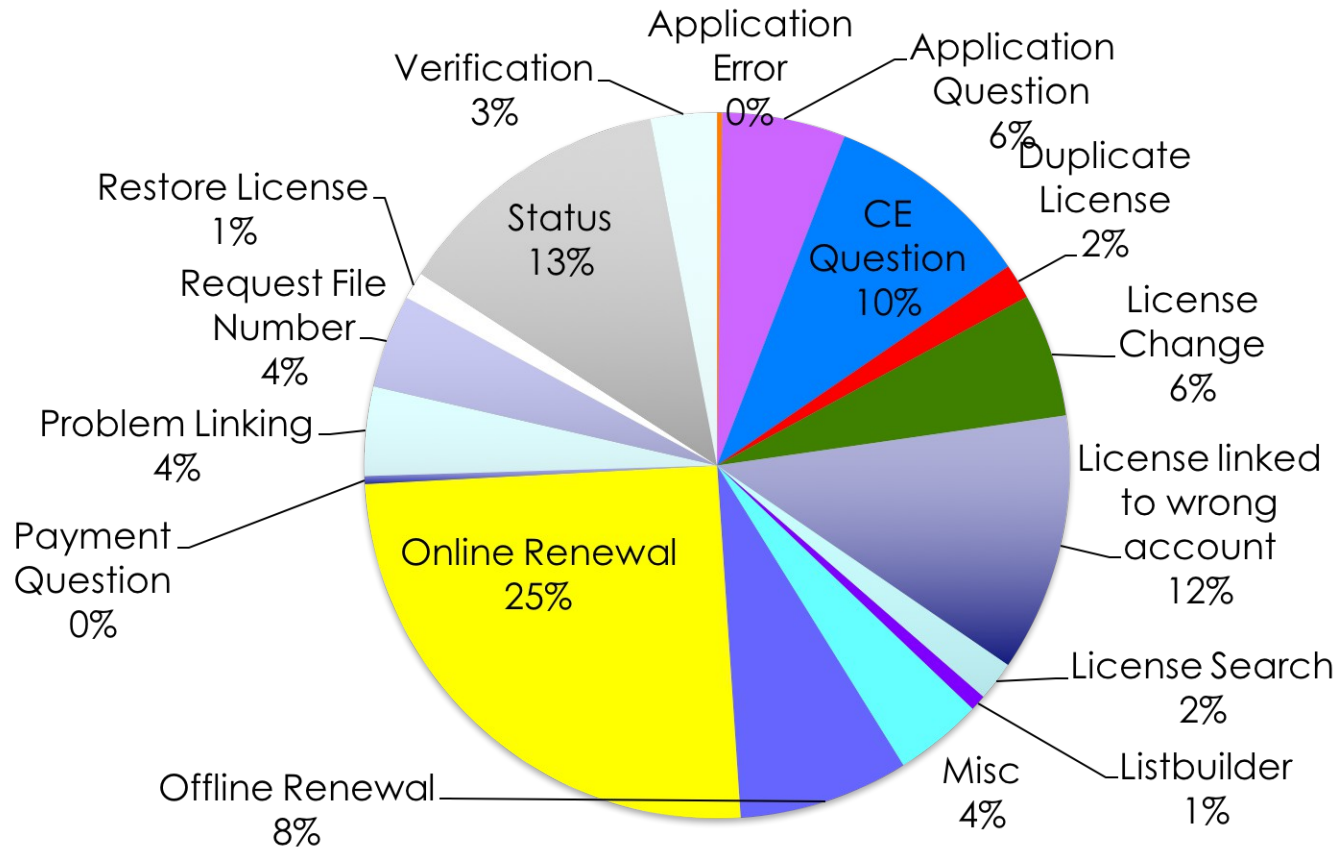
