PURPOSE STATEMENT

This is an amendment to the Statement of Work (SOW) document entitled Online Permitting and Payment Processing Services dated on May 11, 2011 and signed by Robert Fitzgerald, Director, for the Department of Parks and Recreation (PARTNER), Burt Tsuchiya, Director, for the Department of Data Services, Nancy Crawford, Director of Finance, for the County of Hawaii, William Kenoi, Mayor, for the County of Hawaii and Russell Castagnaro, General Manager, for the Hawaii Information Consortium, LLC (HIC).

The purpose of this document is to replace the entirety of the Register Fee, Transaction Fee, or No Fee section of the SOW listed above with the Portal Administration Fee, Transaction Fee, or No Fee section below.

PORTAL ADMINSTRATION FEE, TRANSACTION FEE, OR NO FEE

For all permits there will be a non-refundable Portal Administration Fee of 10% of the total transaction or a minimum of \$2.50, whichever is greater. For all permits, the maximum Portal Administration Fee is \$10.00. If the maximum Portal Administration Fee is reached, there will be an additional 2.5% credit card processing fee added to the total price.

The PARTNER has the option to absorb or pass on the Portal Administration Fee to the fee payer per reservation site.

The proposed fees will be implemented immediately for cabin and bunkhouse permits, specifically at Mauna Kea Recreation Area. The PARTNER and HIC agree to meet and re-negotiate the current fees for all other permits no later than July 1, 2017.

HIC will attempt to collect any rejected payments directly from the customer, however in the event that HIC is not able to collect the fees, any costs incurred by HIC associated with cancelled or insufficient payments will be invoiced to the PARTNER. Returned ACH fees are \$9.00 and returned credit card fees are an additional 2.25% of the total price or a minimum of \$9.00, whichever is greater. These fees are the only costs to the PARTNER associated with this service.

The proposed fees cover the costs associated with the transaction processing, building, maintaining, and hosting of the application, and marketing and customer service support.

The Portal Administration Fee shall be deducted from the gross amount collected online before the net amount is remitted to the PARTNER on a weekly basis.
