Janet Pick of HIC asked that the last sentence in section V.B.1, "This was an ongoing cost to the department.", be removed from the minutes. She clarified that there was no cost to the department as this project had not gone live yet at that time. The SOW was to change the fees from being absorbed by the partner to being passed on to the end-users. But because the service was not deployed at that time, HIC did the amendment before it went live, thus the Department did not pay for anything.

Member Brooks made a motion to remove the last sentence under V.B.1, which was seconded by Member Designee Swanson. Member Brooks amended her motion to a motion to approve the minutes with the amendment to V.B.1 by deleting the last sentence, which was seconded by Member Okumura. Vote was taken and the motion unanimously passed.

  - A. Hawaii Information Consortium (HIC) Report

Burt Ramos, HIC General Manager, was out of town, so Janet Pick reviewed the General Manager's report that was submitted with the agenda. She introduced Tony Tran of HIC's program management office. This report covered the following topics.

- Eleven new services and upgrades were added from February to June 2018
- Hawaii State Public Library System received the Communicator Award of Distinction
- HIC upgraded its Transport Layer Security. All applications were upgraded prior to its deadline of June 2018.
- DCCA payments-- in late April, DCCA contracted with another vendor to process all DCCA payments. HIC will cease processing payments for DCCA and will transition payments over to Pacific Point payment solution.
- Electronic Remittance to Partners—HIC's goal is to eliminate manual check distribution via automation
- The Customer Service Statistics have been expanded in response to Chair Nacapuy's comments at a prior meeting.
- HIC's contract has been extended for one year through January 2020.
