OVERVIEW

This Statement of Work (SOW) document identifies the responsibilities between the Office of Enterprise Technology Services (ETS) and the Hawaii Information Consortium, LLC dba NIC Hawaii ("NIC HI") as the selected vendor providing Internet Portal services for the State of Hawaii. This document is subordinate to the requirements stated in RFP-08-11-SW, Internet Portal Manager and Service Provider, NIC HI's Proposal and the contract between the State of Hawaii and NIC HI dated December 3, 2007.

This Statement of Work covers specific topics that deal with supporting the state's efforts to generate the Consolidated Annual Financial Report (CAFR) for fiscal year 2020.

SERVICE LEVEL AGREEMENT

This Statement of Work is subordinate to the Service Level Agreement (SLA) between ETS (formerly known as the Office of Information Management Technology) and NIC HI signed and dated on September 6, 2012 and is subject to all terms and conditions thereof unless specifically designated as exceptions in this document.

BACKGROUND

The CAFR is a comprehensive presentation of the State of Hawaii's financial activities during the past fiscal year. The year's report has been submitted to the Government Finance Officers Association of the United States and Canada (GFOA) to determine if it meets the reporting requirements to be awarded a Certificate of Achievement for Excellence in Financial Reporting. The Certificate of Achievement is a prestigious national award that recognizes conformance with the highest standards for preparation of state and local government financial reports.

This report is prepared in accordance with Accounting Principles Generally Accepted in the United States of America (GAAP), as prescribed in pronouncements of the Governmental Accounting Standards Board (GASB).

PURPOSE STATEMENT

Work with the state's auditor (Accuity, LLP) with information (reports, audits, etc.) on any portal services that are within the scope of the annual CAFR.

SCOPE STATEMENT

The Department of Accounting and General Services (DAGS) has contracted with Accuity, LLP to assist with the development of the annual CAFR. NIC HI will work with Accuity, LLP to provide information on services that are covered within this year's CAFR.
