BACKGROUND

- 1993 Hawaii Revised Statute, introduction of procurement laws
- Act 216, SLH 2004 required the procuring officer to verify compliance (IFB, RFP, PS, SP, SS)
 - 103D-310(c) required compliance with provisions of:
 - Dept. of Taxation (DOTAX) – Form A-6
 - Department of Labor & Industrial Relations (DLIR) – Form LIR27
 - Department of Commerce & Consumer Affairs (DCCA) – Form COGS
 - Internal Revenue Service (IRS) – Form 8821
- Only paper documents available
- HCE launched in 2005
- Act 190, SLH 2011 required proof of compliance of \$2,500 or greater
- No cost to the State.
 - Vendors pay an annual fee (\$15 in 2005, decreased to \$12 in 2007)

HAWAII COMPLIANCE EXPRESS OBJECTIVE

- Create an online system that would integrate the systems of DOTAX, DLIR, DCCA & IRS, resulting in a single compliance status
- Real-time compliance status available 24/7
- Available to all government entities (with login and password)

BENEFITS TO HCE

- Online forms available 24/7
- Online compliance certificate available 24/7
- No physical interaction
- Quicker status updates for each agency

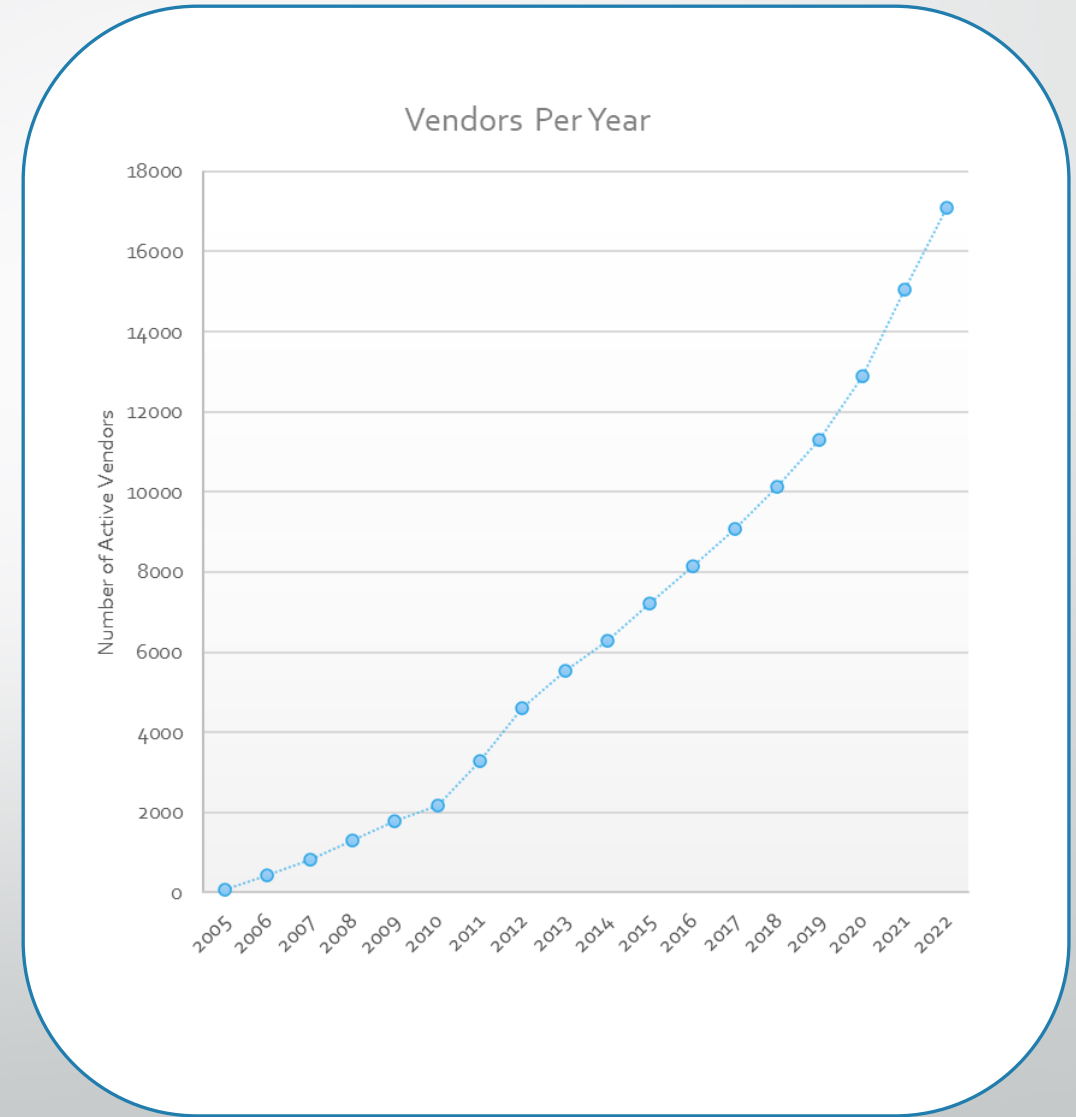

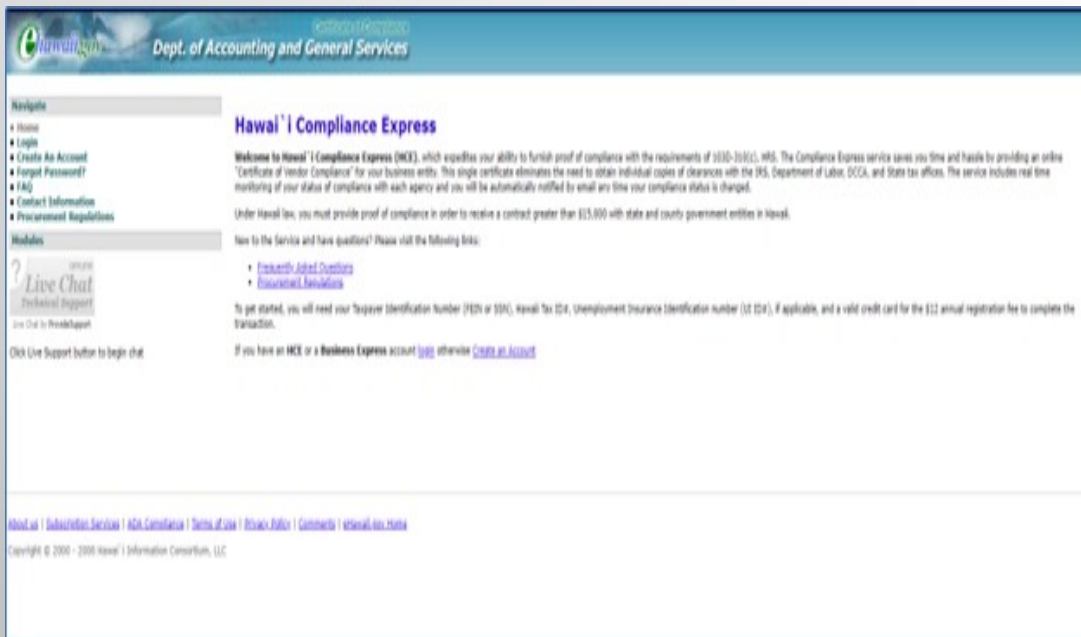

IMPROVEMENTS continued...

- February 2021 – updated DLIR Workflow
- February/March 2021 – Updated IRS Workflow
- March 2021 – Implement digital signatures to IRS Form 8821 (no longer mailing hard copies)
- April 2021 – Display to the vendor the reasons for “not compliant” status by IRS and DLIR
- 2022- Changed font to allow for Hawaiian characters
