SCOPE OF WORK AND DELIVERABLES

Scope

The goals of the requested service is to establish a statewide program that permits the posting of monetary bail twenty-four hours a day, seven days a week, for defendants for whom a monetary amount of bail has been set by the police, other law enforcement agency, court and are in the custody of the Department of Public Safety.

NIC HI's payment service will allow customers to pay bail amounts online via credit card. The STATE staff will communicate with each customer to verify the correct bail amount and ability to pay. If these conditions are met, the STATE staff will log into the NIC system to generate an invoice, which is then sent as a link via email to the customer. The customer will make payment and receive a receipt that then allows them to work directly with the STATE on the next steps to initiate the release process by the Department of Public Safety.

STATE will have an Admin Module to search and view completed transactions.

The system will allow the STATE to view and/or download completed transactions.

Delivery

The STATE shall have fifteen (15) working days to review each deliverable and to either notify NIC HI of acceptance, or to provide NIC HI a detailed list of deficiencies that must be remedied prior to payment being made. In the event the STATE notifies NIC HI of material, non-compliance with the functional specifications, NIC HI shall correct the same within fifteen (15) working days, unless the STATE consents in writing to a longer period of time.

For all credit card transactions completed, there will be a Transaction Fee of 5% plus a 2.5% credit card fee per transaction due and payable to NIC HI.

Predicted transactional revenue:

Ex. The maximum bail payment amount allowed is \$1,000. When \$1,000 is used as an example; the collection fee equals \$1,000 bail payment + ($$1,000 \times 5\%$ transaction fee) + (($$1,000 + $1,000 \times 5\%$) x 2.5% credit card fee) = \$1,076.25 total user fee

Projected annual NIC HI revenue:

NIC is conservatively projecting approximately 10 payments per month, for a total of 120 transactions in the first 12 month period. Based on these numbers and using the maximum bail payment allowed of \$1,000, the projected annual revenue for the first year is calculated:

 $76.25 \times 120 \text{ transactions} = 9,150 \text{ NIC HI annual revenue}$

The Transaction Fee will be an add-on fee for each transaction, and therefore will be paid by end users. The STATE may choose to absorb some or all of the Transaction Fees for a period of time due to COVID-19 or other factor(s). A Memorandum of Understanding (MOU) between NIC-HI and the STATE will be created to document any fee changes and approved by the AHC as needed.

The Transaction Fee shall be deducted from the gross amount collected online before the net amount is remitted to STATE on a set calendar basis via ACH. The frequency and method of remittance can be modified upon mutual agreement and signed agreement between NIC HI and STATE.
