- Allows County of Kauai to accept online payments, track transactions, and view reports


#### Hawaii Digital Government Summit

- Phase 2.2 is currently in progress to migrate 80+ eHawaii.gov services to use the State's SSO login; expected completion in February 2025
  - All SSO integration changes completed in test environment for portal services
  - ForgeRock Ping Identity authentication development and testing complete
  - ForgeRock user interface design work complete and implemented in staging environment
  - $\circ\,$  Final testing in progress and on track for SSO go live




