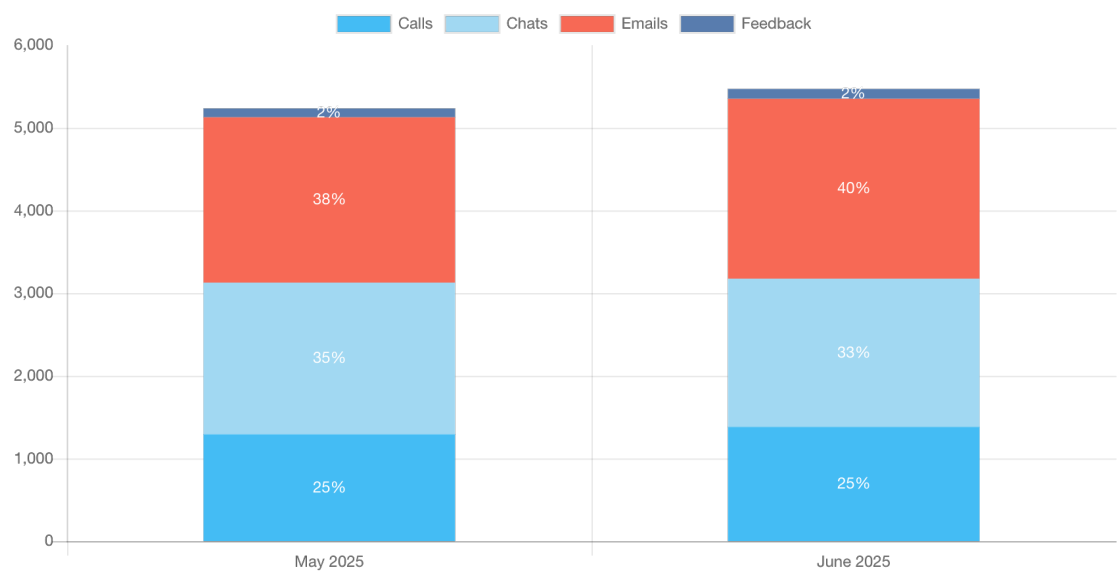
Department of Transportation - Airport Payments

- Payment integration that allows Credit Card payments for airport personnel when renewing their badges.
- Previous payments accepted was Cash or Paper Check only.

Motor Vehicle Registration Renewals - Road Usage Charge

- Launch date: 07/18/25
- Benefits to agency
 - New application programming interface is more reliable with the capability to handle high volume real time requests
 - Makes troubleshooting issues much easier to discover and fix
 - Provides electric vehicle drivers with flexible ways to pay Hawaii's road usage charge, a new per-mile fee for EV owners
- Benefits to users
 - Stable Motor Vehicle Registration Renewal system
 - Allows out-of-state users to renew online

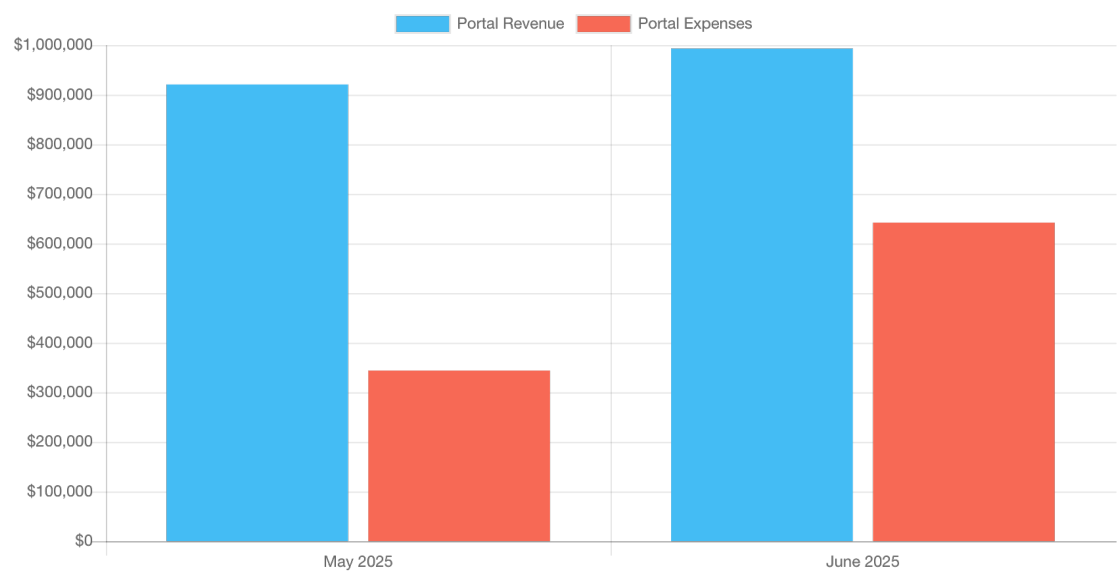

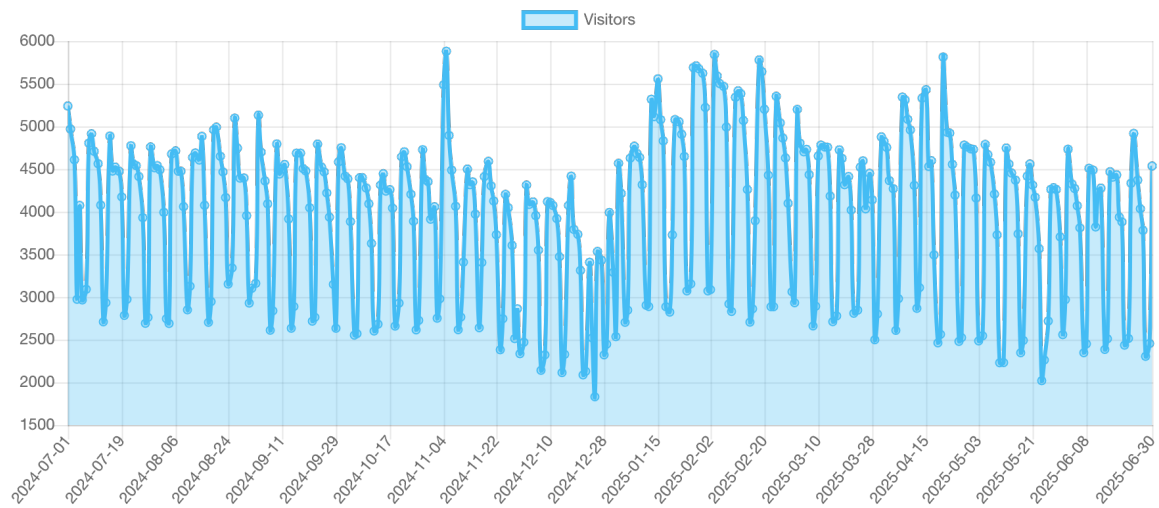
