① Background

- The State Procurement Office Hawaii Awards & Notice data system combines multiple procurement platforms and procurement requests into a centralized location
- Bidding Opportunities are classified by Island and Nationwide
- Contract Awards are grouped based on Category (Construction, Goods, Goods, Services & Construction, Health and Human Services, Services, Goods & Services, Professional Services)
- CPO (Chief Procurement Officer) requests for the Executive Branch are organized by procurement Type (Exemption 103F, 103D, Emergency, Crisis, Sole Source, Restrictive)
- *Launched in 2017, the Hawaii Awards & Notices Data System continues to get updates including managing and tracking Hawaii Compliance Express (HCE) status, Contractor Performance, as well as small business registration*

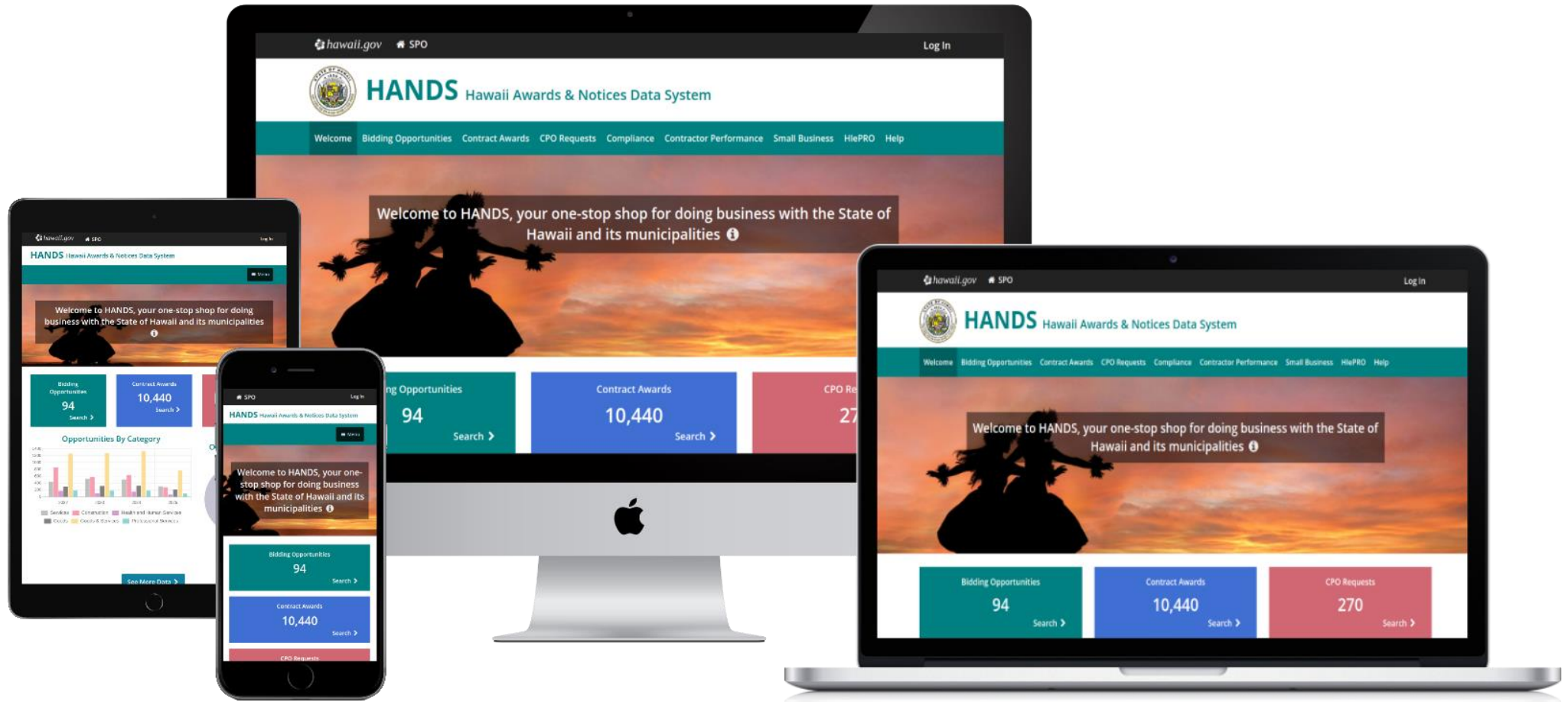
Challenges & Objectives

- Initial Challenges
 - Procurement requests were documented in two legacy systems Professional Services Awards Database and Procurement Awards and Notices Database
 - Buyers posted requests in multiple places/sites while tracking bidding opportunities on multiple procurement platforms
- Objectives
 - Create a single source of truth for viewing, bidding, and managing procurement requests
 - Search procurement opportunities and awards from various jurisdictions throughout the state

Solution



- The Hawaii Awards Notices Data System connects the public to Hawaii's state and counties' opportunities
- Public **users / vendors** can:
 - Search for opportunities to do business with the state or county
 - Browse notice solicitations and awards
 - Register to be a part of the State's small business registration
- Procurement **staff** can:
 - Submit procurement request
 - Post new solicitations
 - Post, amend, and cancel award notices

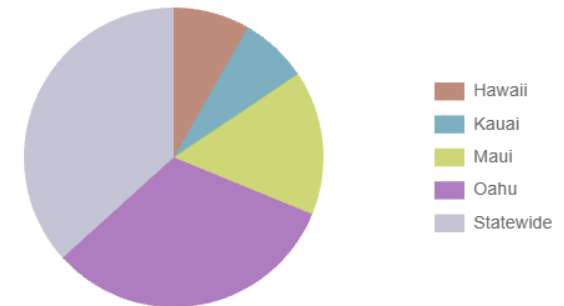

Hawaii Compliance Express (HCE)

Hawaii Compliance Express (HCE), the State's online compliance portal and easiest way to provide proof of compliance for awarded State and County contracts. Pursuant to HRS 103D-310(c) proof of compliance is required at the time of award and for final payment of contracts and procurements of \$2,500 or more for the Executive Branch (\$25,000 for other Jurisdictions).

Hawaii Compliance Express is an optional program, all vendors retain the rights to provide paper documentation form the required departments. Original paper documents are only good for 6 months from effective stamp. Compliance certificates through HCE are available anytime for one calendar year. Awarding agencies will be able to pull their own HCE certificate alleviating this burden from vendors.



The only requirement to start the HCE process is an FEIN/SSN and a valid credit card to process the \$12 annual subscription. Please view the [HCE FAQs](#) for more information.



Small Business Initiative



What is the Small Business Initiative?

The small business initiative was established to ensure that small businesses, including businesses owned by veterans, native Hawaiians, and women, are able to effectively participate in contracting opportunities with State of Hawaii government agencies. Qualified businesses are required to self-register in order to be searchable by government agencies.

How to Register

1. Verify that your business meets the [size standards for a small business](#) established by the Small Business Administration.
2. Create an myHawaii Account. Watch the [Create Account](#) video to learn how.
3. Complete the small business registration form.
