  - 1. SOWs Under Review
    - a. County of Kauai Department of Finance Transient Accommodations Tax Payments SOW

The County of Kauai seeks to transition to a new system featuring a more user-friendly interface designed to streamline their internal processes. This SOW covers the implementation of an online transient accommodations tax payment service which includes a daily csv export file of successful transactions. Users will enter their transient accommodation (TA) account number, name, record type (TA-1, TA-2), amended return (yes/no), period ending month/year, and taxable proceeds amount. The system will calculate the transient accommodations tax due including any penalties and interest based on the taxable proceeds amount entered.

Development fees: \$0.00

Hosting fees: \$0.00

Maintenance and Support fees: \$0.00

Transaction fees: A fixed cost of \$2.50 per TA number for non-bulk filers or \$2.50 per transaction for bulk filers plus additional 2.5 % credit/debit card fee or \$1.00 eCheck fee per transaction.

 b. Department of the Attorney General – Hawaii Criminal Justice Data Center – Online Sex Offender Public Registry - SOW Amendment 2

The sex offender public registry search web application allows users to search for offenders in Hawaii and has been developed over two decades. This SOW amendment 2 outlines substantial revisions to the application in four phases:

Phase I: Upgrades to the backend infrastructure and redesign of the site.

Phase II: New Custom mapping tools.

Phase III: Alternative search options and new search results displays.

Phase IV: Updates to alerts, print displays, and addition of an administrative module to allow the State to create, edit, and remove notices on the site.

a. Legislative Reference Bureau – Website Redesign PCR 1

This PCR is to update Legislative Reference Bureau's website. This includes accessibility remediation work to ensure compliance with the new accessibility standards, and updates to their site. The development fee is \$5,193.72.

 Department of Land and Natural Resources, Division of Forestry and Wildlife, Hunter Education and Records Management System Application Review

The Go Hunt Hawaii allows individuals to submit electronic applications for the hunting lottery on the islands of Lanai, Hawaii and Kauai. The hunt lottery automates the selection process for annual game hunting opportunities on the island of Lanai. Additional features include registering for hunting classes and events, sharing announcements, and purchasing or replacing certification cards.
