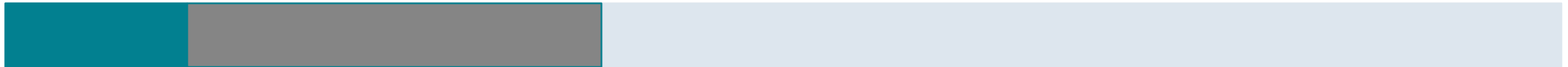

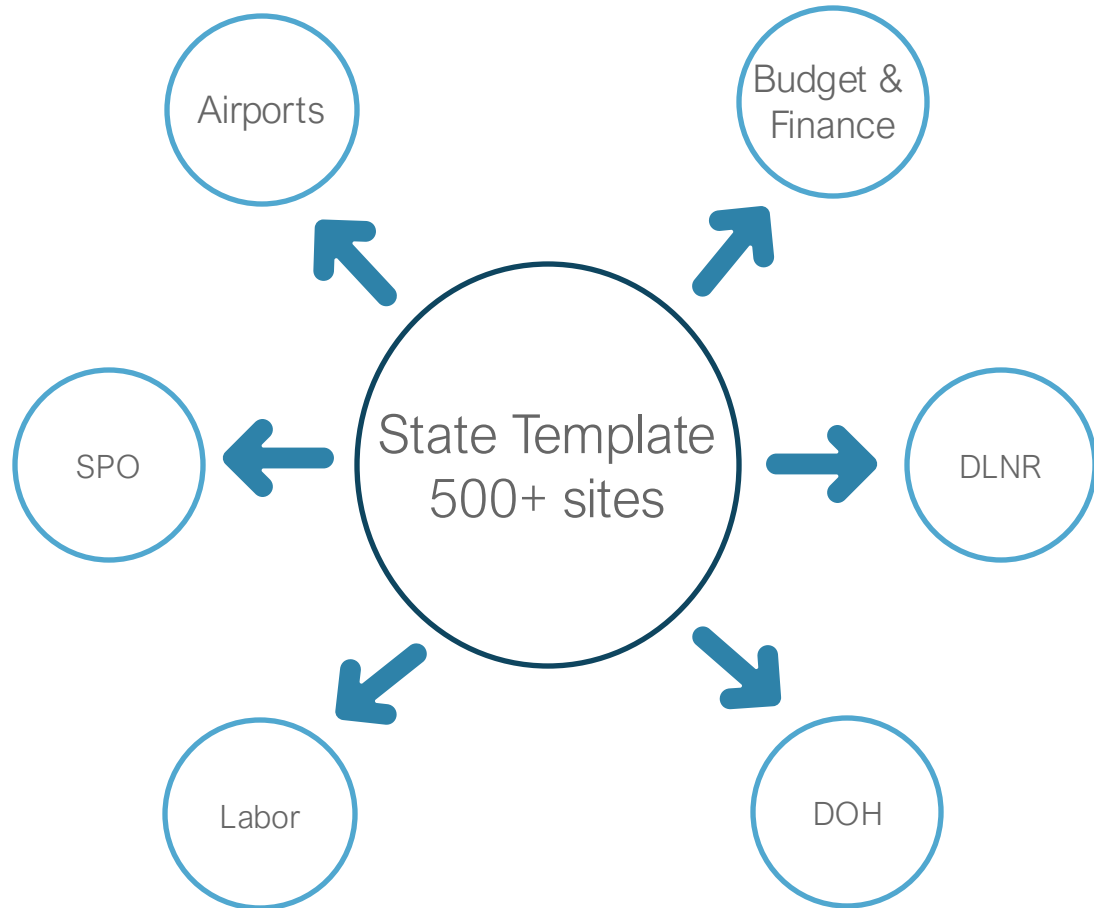

Template changes can be applied globally and deployed across all sites, maximizing the return on investment in accessibility.

Governance and Compliance

Centralized style guide aligns design and development, preventing reintroduction of accessibility barriers across agencies.

Sustainable Digital Modernization

The template creates a modern foundation that supports ongoing content updates and accessibility.

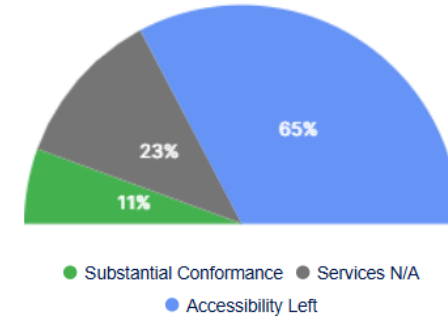

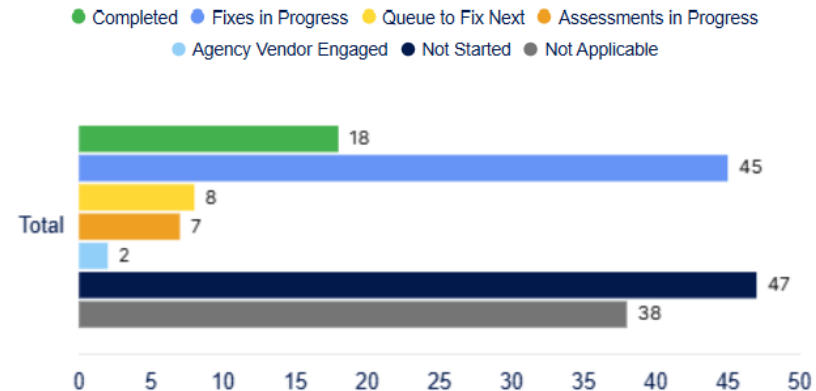

Accessibility Conformance Progress

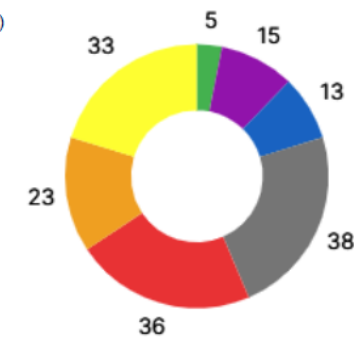


Accessibility Status Counter
